## **Reasons a Trustee May Be Replaced**

A trustee is a person who is endowed with legal ownership and management of a trust's assets, for the benefit and protection of the trust's beneficiaries. But there are a number of circumstances that can lead to the replacement of a trustee:

- The trustee acts in a manner that harms the value of the trust's assets or the interests of the beneficiaries.
- The trustee fails to uphold the terms of the trust.
- The trustee decides to resign during trust administration.
- The trustee is declared incompetent by a court of law.
- The trustee is placed under a conservatorship, which means that another person has been granted court-



ordered authority to manage the affairs of the trustee, who can no longer make their own decisions about finances.

- The trustee files for bankruptcy during the course of trust administration.
- The trustee dies during trust administration.

Beneficiaries wishing to replace a trustee must petition the probate court and attend a court hearing. In some cases, the process of trustee removal can be complicated and is not guaranteed, as the court places great weight on the choice of trustee made by the creator of the trust.

There's an area where golfers can see ancient grinding stones, which the Luiseno used to grind acorns into flour. There are covered bridges, fish ponds, and kiicha huts, which are replicas of small native houses that Luiseno children have built during cultural lessons.

We didn't win the tournament, or even place very well. Scott did win a giant bottle of holiday red wine from Ponte Winery in a putting contest, though, and we had a once in a fascinating day.
