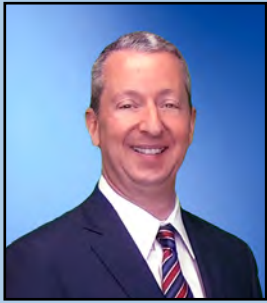

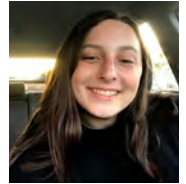

Easy Fruit Cobbler

INGREDIENTS:

- 1/2 cup butter one stick
- 1 cup self-rising flour
- 1 cup sugar
- 3/4 cup milk
- 15 oz can fruit in light syrup or juice do not drain



DIRECTIONS:

1. Preheat oven to 350 degrees.
2. Place butter into 9 X 9 pan and place pan into oven as it preheats. This melts the butter and lubes up the pan to prevent the cobbler from sticking.
3. Mix together the flour, sugar, and milk.
4. Once the butter is melted, and the oven preheated, pour the flour/sugar/milk mixture into the pan.
5. Add the can of undrained fruit, pie filling, or other fruit into the middle of the mixture.
6. Add extra sugar or cinnamon-sugar to the top if desired and place into oven.
7. Bake approximately 30 to 45 minutes or until the top is golden brown and the biscuit part is cook through.

10 Minute Great Potatoes

INGREDIENTS:

- 3 tablespoons mayonnaise
- 2 cloves garlic, crushed
- 1 teaspoon dried oregano
- salt and pepper to taste
- 5 potatoes, quartered



DIRECTIONS:

1. In a small bowl, mix mayonnaise, garlic, oregano, salt, and pepper. Set aside.
2. Bring a large pot of salted water to a boil. Add potatoes, and cook until almost done, about 10 minutes. Don't overcook otherwise the potatoes will break apart. Drain, and cool.
3. Preheat oven broiler. Line a baking tray with aluminum foil, and lightly grease the aluminum foil.
4. Arrange potatoes in the prepared baking tray. Spoon the mayonnaise mixture over the potatoes. Place on the prepared grill, and cook until potatoes are tender and mayonnaise mixture is lightly browned, about 10 minutes

DIY Wine Cork Utensil Holder

SUPPLIES:

- Empty tin can, washed and dried. This is a larger soup can or a can for pie filling or beans/tomatoes/vegetables.
- Natural corks, vs. synthetic
- Wax paper



INSTRUCTIONS:

1. Cover a flat surface with wax paper to protect it.
2. Place your can onto the surface and place corks around the can making sure they fit. Leaving your can upright, place the hot glue on the cork and press onto the can, keeping the bottom row of corks flat to the bottom of the table. Let the glue set a bit. Flip the can over and add hot glue where the corks meet. Let set to harden.
3. Return the can to the upright position and continue to place corks, on top of the bottom row. Add hot glue to the cork and press firmly onto the can. Continue until the entire can is covered.
4. Once at the top of the can, you may have about 1/4' to 1/2" of the can to work with. Add glue to the top of the can and press corks firmly onto the can. Let set so the glue can harden.
5. Fill your can with your favorite kitchen utensils, flowers, plants, or pencils.

DIY Sharpie Tie Dye Shoes

SUPPLIES:

- colorful set of Sharpie markers (you can order these from Amazon)
- plain white canvas shoes
- rubbing alcohol
- spray bottle
- masking tape



DIRECTIONS:

1. cover the rubber sole of your shoe with masking tape to keep the colors from running onto it
2. use the Sharpie markers to color your design on your shoes
3. use spray bottle with rubbing alcohol to make the colors run all over the shoe
4. allow to dry
5. repeat if necessary, until you're happy with the results

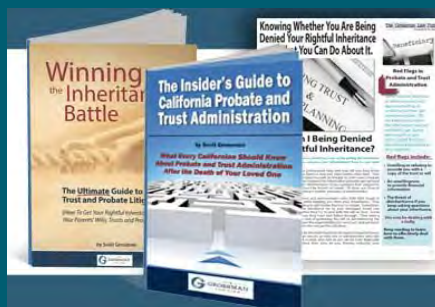

7 Factors That Impact The Cost Of An Ancillary Probate

- 
1. The size of the ancillary probate estate. In some cases, the larger the estate, the more fees may be incurred.
 2. Whether there are any disputes between beneficiaries or creditors surrounding the ancillary probate administration in San Diego.
 3. The type of property located within California. For example, it may be easier to administer the ancillary probate if the property consists only of bank accounts, rather than interests in a small business.
 4. Whether the property has to be sold as part of the ancillary probate administration. There are sometimes not sufficient liquid assets in order to pay for the costs of administration, requiring property to be sold.
 5. Furthermore, whether complex appraisals are needed for the probate administration or for tax purposes.
 6. Additionally, whether the heirs or beneficiaries are easily located and cooperative.
 7. Lastly, whether you have the assistance of an experienced attorney. It may seem counter-intuitive, but hiring an attorney can often save you money, since the ancillary probate proceedings can be carried out more quickly and efficiently.
