APPLE PIE ROLL UPS

INGREDIENTS:

- 6 pieces of sandwich bread-I use potato bread usually
- Cinnamon sugar-I make my own to keep on hand by combining 1 cup of sugar with 3 tbsp ground cinnamon
- 3 tbsp butter, melted on a plate
- 1 large or 2 small apples, cut into 1 cm cubes

DIRECTIONS:

- Preheat oven to 350 degrees and prepare a baking sheet with parchment paper.
- Use a rolling pin (or your hand!) to flatten the slices of bread.
- Divide the apples between the bread slices and sprinkle each with 1 tsp of cinnamon sugar. Carefully roll the bread around the apples and place in the butter on all sides, then in the cinnamon sugar to coat.

1/2 tsp Salt

• 1 tsp Vanilla

• $1/2 \operatorname{cup} \operatorname{Oil}$

• 1/2 cup Pecans

• 2 tbsp Butter

- Place on the baking sheet.
- Bake for 15 minutes or until crisp.
- Let cool 5 minutes and serve warm.

INGREDIENTS:

- 1 cup Pumpkin puree
- 2 tsp Baking powder
- 1/2 cup Brown sugar
- 2 tsp Cinnamon
- 2 1/8 cups Flour
- 3/4 cup Granulated sugar 1/2 cup Milk
- 1 tbsp Pumpkin pie spice

DIRECTIONS:

- Preheat oven to 350 degrees.
- Whisk together dry ingredients in a mixing bowl. Dump in pumpkin puree, milk, oil, and vanilla and then mix until well incorporated.
- Pour into a lightly greases 9x9 pan.

For Streusel

- Melt butter in a microwave safe bowl. Add brown sugar, flour, and cinnamon and mix until incorporated. Mix in chopped pecans.
- Sprinkle evenly on top of cake batter. Note: You can leave it on the top when cooking, or I prefer to lightly poke it (with a finger- poke, do not stir) into the batter in several places. I like the taste of having the streusel areas within my cake. The texture is so good.
- Bake for 30-40 minutes or until toothpick inserted in the middle comes out with just a few moist crumbs.

Fall Mason Jar Lights SUPPLIES:

- Mason Jars
- **Rubbing Alcohol**
- Sponge Brush
- Hodge Podge
- Leaves



INSTRUCTIONS:

First, make sure the outside of your jar is clean. Wipe it gently with rubbing alcohol to get any grease and grime off the outside of the jar. The leaves won't stick if the jar is oily or dirty. Then make sure your leaves are malleable. Bend them a little bit to loosen them up. Stiff leaves won't stick either. If they are thin, fabric leaves, they should easily form around the jar. If they are real leaves, you may want to dampen them slightly (almost the way leaves become after it rains) to unstiffen them. You can also iron fabric leaves as well to loosen the fibers.

To decoupage, dip your brush in the Mod Podge and paint a thin layer on a section of the jar. Once that layer becomes quite sticky (check by dabbing your finger on it), place a leaf on the jar. Paint more Mod Podge on top of the leaf in thin layers, making sure to smooth out the edges. Start in the center of the leaf, and push your way out to the edges with your fingers. It may take a few layers, but the leaf should stick to the jar. I had to press a few times to get the leaves to stick; but as the Mod Podge dries, it should.

Stacked Pumpkin Planter SUPPLIES:

- Pumpkins 4 from the dollar store
- Spray paint in the color of your choice
- Outdoor adhesive vinyl
- Cricut or another craft cutter
- Scissors
- Clear adhesive good for outdoors
- Rocks
- Flowers

DIRECTIONS:

- 1. Spray paint your pumpkins any color that you desire. We used a fun metallic spray paint. Paint on all sides.
- Allow those to dry completely.
- 3. Use your Cricut or another cutting machine to cut out the letters FALL fromadhesive outdoor vinyl. or buy premade letters or paint on letters by hand.
- Cut the handles off of each of the pumpkins with scissors.
- Fill the bottom two pumpkins about half full with rocks.
- Secure pumpkins together with a clear adhesive that is okay for outdoor use. Stack four high.
- Allow the adhesive to cure completely. Be sure to follow your package instructions for cure time.
- Add the vinyl letters to the front of your pumpkin stack.
- 9. Add in your flowers and your stacked pumpkin planter is complete.

What Is Ancillary Probate And When Is It Needed In California?

Ancillary Probate must be done if a deceased person has property in more than one state. It must also be done if they die in one state and own property in another. For this situation the main probate is typically done in the state where the deceased person resided and an Ancillary Probate is done in the state where the property was owned. This requires that the estate pay for Probate costs in each state.



Ancillary Probate is a secondary probate which must be opened when a resident of another state dies and he owned property in California. Probate must be opened in the place where a person lived. So, if a person lives in Washington State, for example, probate must be opened there. A Washington judge is not able to make orders concerning the transfer of property in California. A California judge must make those orders.

If a person owns property that is not held in a trust, his signature is required in order to transfer that property. That obviously isn't possible in the case of a death, so probate serves as a substitute for that signature.

Primary probate occurs where the person lives. The primary probate disposes of most of the decedent's property, but a California attorney must go into court to open up a secondary, or ancillary, probate in California in order to handle the California property.

From there, probate proceeds and the terms of the decedent's will are carried out. If the will stated that a particular beneficiary receives the California property, that is what happens. Or, if the will states that the property should be sold and certain beneficiaries share the proceeds of the sale, the California judge can make that order.
